Employment in Clatsop County: June 2019

Employment Fell by 60 more than Expected in June

Seasonally adjusted nonfarm payroll employment decreased by 60 jobs in June to 19,060 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 620 jobs was expected for the month, but the county added only 560 jobs. The private sector grew by 540 jobs, and total government employment increased by 20. Leisure and hospitality gained 250 jobs, professional and business services grew by 80, other services was up by 70, and retail trade and food manufacturing each grew by 60 jobs. Other industries had smaller changes.

June's total nonfarm employment numbers show a gain of 210 jobs compared with one year before, an increase of 1.1 percent. The industries gaining the most jobs over the year were leisure and hospitality (+160 jobs) and construction (+90 jobs). Industries losing the most jobs were local government education (-160 jobs), and food manufacturing (-100 jobs).

Clatsop County's seasonally adjusted unemployment rate was 4.1 percent in June, unchanged from the previous month (4.1%) and essentially the same as the year before (3.9%). The county's rate was also the same as the statewide rate (4.1%) and close to the national rate (3.7%).

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
