Employment in the Columbia Gorge: April 2018

Leisure and Hospitality Leads the Way in April

Hood River County's seasonally adjusted unemployment rate held steady in April at 3.2 percent, ranking third (out of 36 counties). Over the year, Hood River County's seasonally adjusted unemployment rate fell by 0.5 percentage point.

Hood River County gained 80 nonfarm jobs in April, rising to 11,790. Food services and drinking places led private industry, rising by 90 jobs to total 1,180. Mining, logging, and construction rose by 40 jobs to reach 500, and retail trade produced a gain of 40 to total 1,390. Professional and business services (+30) and transportation, warehousing, and utilities (+20) also rose in April. Arts, entertainment, and recreation cut 190 jobs in April, falling to 840. Government rose by 30 jobs in April to total 1,400.

Private industry employment rose by 350 jobs over the year ending in April to total 10,390, an increase of 3.5 percent. Leisure and hospitality led private industry with an over-the-year gain of 110 jobs. Education and health services increased its job total by 90, rising to 1,650. Mining, logging, and construction (+60), professional and business services (+60), and wholesale trade (+40) earned honorable mention.

Wasco County's seasonally adjusted unemployment rate held steady at 4.1 percent in April, ranking 10th among Oregon counties, tied with Morrow and Clatsop. Wasco County's seasonally adjusted unemployment rate rose slightly over the year, up 0.2 percentage point, although it ranked seventh in April 2017.

Nonfarm payroll employment rose by 190 jobs in April, increasing Wasco County's total to 10,400. Private industry rose by 180 jobs, reaching 8,360 and government managed a gain of 10, rising to 2,040. Accommodation and food services led private industry in April, rising by 80 jobs to total 1,270. Construction (+20), manufacturing (+20), retail trade (+20), and professional and business services (+20) all produced job gains in April. Indian tribal government rose by 20 jobs in April but local education cut 10.

Over the year, Wasco County's nonfarm employment total rose by 50 jobs, with government cutting 210 and private industry rising by 260. Professional and business services rose by 70 jobs over the year to reach 560, an increase of 14.3 percent. Education and health services rose by 70 to 2,330, thanks in part to the inclusion of home care workers; state government lost 100, falling to 250. Accommodation and food services rose by 50 jobs over the year and other services also rose by 50 to reach 420.

Gilliam County's seasonally adjusted unemployment rate fell by 0.2 percentage point in April to 3.2 percent, ranking third among Oregon's 36 counties. Last April, Gilliam County's seasonally adjusted unemployment rate ranked 12th, at 4.2 percent. Gilliam County's nonfarm employment rose by 15 jobs in April to 795; with 555 jobs in private industry and 240 in government. Over the year, professional and business services rose by 40 jobs to reach 220; trade, transportation, and utilities rose by 10; and education and health services gained five. State government lost 10 jobs over the year and local government also cut 10.

Sherman County's seasonally adjusted unemployment rate rose to 3.9 percent, ranking ninth. Last April, Sherman County's seasonally adjusted unemployment rate ranked 22nd at 4.8 percent. Sherman County's nonfarm employment rose by five jobs in April to reach 810, led by an increase of 10 in leisure and hospitality. Over the year, private industry lost 20 jobs, falling to 480, with trade, transportation, and utilities cutting 25 jobs, falling to 215. Government shed 15 jobs over the year, falling to 330.

Wheeler County's seasonally adjusted unemployment rate rose by 0.1 percentage point in April to 3.0 percent, Oregon's lowest. Wheeler County's seasonally adjusted unemployment rate ranked 16th in April 2017 and was 1.4 percentage points higher, at 4.4 percent. Nonfarm employment rose by five jobs in April to 285. Over the year ending in April, private industry held steady at 160, while government cut five, falling to 125.

Note: Effective with the January 2018 data, employment of Oregon's approximately 17,000 home care workers are counted in private health care and social assistance instead of state government. The change was due to legislative action clarifying that for purposes of workforce and labor market information, home care workers are not employees of state government. The reclassification affects private sector and government monthly change figures for January 2018 and will affect over-the-year change figures through December 2018. It does not affect total payroll employment levels.

Next Press Releases

The Oregon Employment Department plans to release the May 2018 county and metropolitan area unemployment rates on June 19th, 2018 and the statewide unemployment rate and employment survey data for May on June 12th, 2018.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
