## **Employment in Lincoln County: April 2018**

### **Employment Short by 70 Less than Expected in April**

Seasonally adjusted nonfarm payroll employment decreased by 70 in April to 18,410 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 310 jobs was expected for the month, but the county added only 240 jobs. Private sector employment rose by 220 jobs, and government employment was up by 20. Leisure and hospitality added 170 jobs, and retail trade chipped in 30 jobs. Food manufacturing dropped 30 jobs. Other industries had smaller changes.

April's total nonfarm employment was 150 more than one year before, an increase of 0.8 percent. The private sector added 480 jobs, and government employment fell by 330. Industries adding the most jobs over the year were leisure and hospitality (+140), and construction (+90). Trade, transportation, and utilities lost 50 jobs over the year.

Lincoln County's seasonally adjusted unemployment rate was 4.7 percent in April, essentially the same as the previous month (4.8%), and the year before (4.6%). The rate was higher than the statewide rate (4.1%) and the national rate (3.9%).

Labor Force Status: Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes nonfarm payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
