## **Employment in Corvallis MSA (Benton County): May 2025**

## Benton County's Unemployment Rate Remains at 3.9%

Benton County's seasonally adjusted unemployment rate was 3.9% in May, matching its April rate of 3.9%. Oregon's statewide unemployment rate in May was 4.8%, up from its April rate of 4.7%.

Benton County's employment gains in May were more than normal; total nonfarm employment increased by 270 jobs, when an employment increase of 160 jobs would be expected. As a result, seasonally adjusted employment increased 110 jobs between April and May. Seasonally adjusted total nonfarm employment is now up 3.5% from the level in February 2020, 1,520 jobs above its pre-pandemic level.

Over the past year Benton County's seasonally adjusted total nonfarm employment is up 500 jobs or 1.1%.

The private sector overall added 250 jobs over the month. Leisure and hospitality added 150 jobs. Trade, transportation, and utilities employment increased by 50 in May.

The public sector overall added 20 jobs in May. State and local government employment both increased by 10. Local education shed 20 jobs.

The most recent month is preliminary, the prior month is revised. Prepared in cooperation with the U.S. Department of Labor, Bureau of Labor Statistics.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
