**Employment in Clatsop County: May 2025** 

## Seasonally adjusted employment decreased by 60 in May

Seasonally adjusted nonfarm payroll employment decreased by 60 in May to 19,340 jobs. Seasonally adjusted figures compare expected changes with actual changes. An increase of 410 jobs was expected for the month, and the county gained 350 jobs. The private sector gained 310 jobs while total government employment increased by 40. Manufacturing increased the most with a gain of 140 jobs. Leisure and hospitality added 130 jobs. Local government increased by 50 jobs.

May's total nonfarm employment was down from the previous year by 220 jobs (-1.1%). Some major industries gained jobs over the past year, but others have plateaued or shed jobs. Private education and health services had the largest gain, adding 100 jobs over the year (+3.7%). Paper manufacturing added 30 jobs (+4.1%). The largest decline was in food services and drinking places, which lost 150 jobs (-4.5%). Local education lost 60 jobs (-5.2%).

Clatsop County's seasonally adjusted unemployment rate was 4.6% in May, up from 4.5% in April, and above the rate of 4.1% in May 2024. The statewide unemployment rate was 4.8% in May, and the national rate was 4.2%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
