Employment in Clatsop County: June 2025

Seasonally adjusted employment decreased by 110 in June

Seasonally adjusted nonfarm payroll employment decreased by 110 in June to 19,260 jobs. Seasonally adjusted figures compare expected changes with actual changes. An increase of 450 jobs was expected for the month, and the county gained 340 jobs. The private sector gained 350 jobs while total government employment decreased by 10. Manufacturing increased the most with a gain of 140 jobs. Leisure and hospitality added 160 jobs. State government increased by 20 jobs.

June's total nonfarm employment was down from the previous year by 330 jobs (-1.6%). Some major industries gained jobs over the past year, but others have plateaued or shed jobs. Private education and health services had the largest gain, adding 90 jobs over the year (+3.3%). Professional and business services added 70 jobs (+6.6%). The largest decline was in food services and drinking places, which lost 220 jobs (-6.3%). Local education lost 70 jobs (-6.1%).

Clatsop County's seasonally adjusted unemployment rate was 4.7% in June, up from 4.6% in May, and above the rate of 4.1% in June 2024. The statewide unemployment rate was 4.9% in June, and the national rate was 4.1%.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
