Employment in Morrow & Umatilla Counties: December 2025

Morrow County's seasonally adjusted unemployment rate was 4.9% in December and 4.9% in November. The December rate ranks it in a tie with Deschutes County for 4th lowest among Oregon's 36 counties. Morrow County's rate is up from 4.0% in December 2024. The Oregon rate was 5.2% in December and the U.S. rate was 4.4%.

Morrow County's seasonally adjusted nonfarm employment decreased by 20 in December to reach 5,880. In the not seasonally adjusted industries, there was a significant loss of 20 in construction.

Morrow County's employment increased by 10 jobs over the year ending in December. Private industry dropped 60 jobs, while the public sector increased by 70. There were losses in professional and business services (-150) and manufacturing (-110). There were gains in construction (70) and transportation, warehousing, and utilities (60). Government employment rose by 70 jobs over the year, due to an increase in local government of 70.

Umatilla County's seasonally adjusted unemployment rate was 5.6% in December and 5.6% in November. The December rate ranks 19th lowest among Oregon's 36 counties. Umatilla County's seasonally adjusted unemployment rate is up from 4.7% in December 2024. The Oregon rate was 5.2% in December and the U.S. rate was 4.4%.

Umatilla County's seasonally adjusted nonfarm employment dropped 20 jobs in December to reach 30,060. In the not seasonally adjusted private sector industries, there was a seasonal loss of 80 in mining, logging, and construction. Government dropped by 100 due to losses in local education (-60), federal government (-30), and other local government (-20) that were countered by a gain of 10 in Indian tribal.

Umatilla County's employment dropped 80 jobs over the year ending in December. Private industry decreased by 210 jobs since December 2024. There were significant losses in retail trade (-80), professional and business services (-80), and leisure and hospitality (-70). There were gains in information (60) and manufacturing (30). Government employment rose by 130 jobs over the year due to gains in local education (110), state government (10), and Indian tribal (10).

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
