Employment in Morrow & Umatilla Counties: May 2025

Umatilla County's seasonally adjusted unemployment rate increased by 0.1 percentage point to 5.1% in May. Ranked among Oregon's 36 counties, Umatilla County tied with Linn and Wallowa counties for 22nd. Over the year, Umatilla County's seasonally adjusted unemployment rate rose by 0.7 percentage point. It represented the county's fifth lowest May rate since comparable statistics began in 1990.

Umatilla County's nonfarm employment total rose by 220 jobs to 30,380 in May. Private industry increased by 150 jobs in May, rising to 22,430, and government added 70 jobs to reach 7,950. Leisure and hospitality increased its total in May, climbing to 2,890, a gain of 40. Mining, logging, and construction added 30 jobs, rising to 1,590. Private education and health services also added 30 jobs to total 4,600. In the public sector, other local government increased by 30 jobs, while federal government, state government, Indian tribal, and local education each added 10 jobs.

Umatilla County's total private industry employment increased by 150 jobs over the year ending in May (+0.7%). Private education and health services led private-industry gains, rising by 220 jobs (+5.0%), followed by information, up 90 jobs (+11.5%) over the year. Retail trade led losses, falling by 150 jobs (-4.4%). Manufacturing, and leisure and hospitality dropped 50 jobs each over the year. Government employment decreased by 90 jobs over the year, led by a loss of 130 in local education. Federal government fell by 30 jobs, other local government decreased by 20, state government added 90, and Indian tribal held steady.

Morrow County's seasonally adjusted unemployment rate increased by 0.1 percentage point in May to 4.9%, ranking in a tie with Baker and Tillamook counties for 19th among Oregon counties. Over the year, Morrow County's seasonally adjusted unemployment rate rose by 1.0 percentage point.

Morrow County's nonfarm employment increased to 5,790 in May, a gain of 10 jobs. Private industry increased by 10 jobs, rising to 4,940 jobs, and government held steady at 850. Construction, and transportation, warehousing, and utilities increased by 20 jobs each to lead gains. Manufacturing and professional and business services dropped 30 jobs each to lead losses. In the public sector, federal government, state government, and local government all held steady.

Morrow County's private-industry employment rose by 220 jobs over the year ending in May (+4.7%). Private industry's over-the-year growth was led by a gain in construction, up 70 jobs, followed by gains of 20 jobs each in transportation, warehousing, and utilities; private education and health services; and

leisure and hospitality. Professional and business services dropped 20 jobs to lead losses, followed by manufacturing and wholesale trade, down 10 jobs each. Government employment fell by 280 jobs over the year, with local government shedding 270 jobs, federal government dropping 10, and state government holding steady.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
