## Employment in Columbia County: December 2025

### **Seasonally adjusted employment increased by 10 in December**

Columbia County's seasonally adjusted unemployment rate was 6.1% in December, unchanged from November, and above the rate of 4.7% in December 2024. The statewide unemployment rate was 5.2% in December, and the national rate was 4.4%.

Seasonally adjusted nonfarm payroll employment increased by 10 in December to 12,290 jobs. Seasonally adjusted figures compare expected changes with actual changes. A loss of 70 jobs was expected for the month, and the county's payroll employment decreased by 60. Private-sector employment decreased by 50, and government employment decreased by 10. Retail trade added 30 jobs. Construction lost 20 jobs. Other industries experience little or no change in employment.

December's total nonfarm employment was down from the previous year by 30 jobs, a decrease of 0.2%. Some broad sectors gained jobs over the past year. The largest gain occurred in private education and health services, which added 110 jobs. Professional and business services was down 110 jobs over the year. Local education was up 70 jobs over the year.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
