# **Employment in the Columbia Gorge: March 2025**

Seasonally adjusted unemployment rates saw little movement in the Gorge this March, with slight increases in two of the five counties.

In March, Hood River County's seasonally adjusted unemployment rate increased marginally to 3.7%, up from a revised rate of 3.6%. Hood River County's unemployment rate ranked as Oregon's lowest, just above Sherman's 3.9%. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.4 percentage point.

Hood River County's nonfarm employment increased by 40 (+0.3%) in March and was estimated at 11,920 jobs. Both private employment and public-sector employment increased by 20 over the month.

Hood River County's total nonfarm employment decreased by 310 jobs over the year ending in March, representing a loss of 2.5%. Job losses were concentrated within leisure and hospitality (-160 jobs), with all losses occurring in arts, entertainment, and recreation (-170 jobs); and trade, transportation, and utilities (-70 jobs), with losses taking place primarily within wholesale trade (-90 jobs). Gains were marginal and strongest primarily within professional and business services (+20 jobs) and mining, logging, and construction (+20 jobs).

Wasco County's seasonally adjusted unemployment rate increased in March, going from a revised rate of 4.4% to 4.5%. Over the year, Wasco County's seasonally adjusted unemployment rate is 0.3 percentage point higher.

Wasco County's nonfarm employment increased by 40, totaling 10,300 as of March. Private industry employment gained 20 jobs, bringing employment up to 7,910. The public sector also gained 20 jobs over the month, with government employment now at 2,390. Supersector private job gains were seen in leisure and hospitality (+20 jobs); other services (+10 jobs); private education and health services (+10 jobs); and information (+10 jobs). Losses were minimal and took place in trade, transportation, and utilities (-30 jobs).

Wasco County's private industry employment rose by 110 (+1.1%) jobs over the year ending in March. Gains were mainly concentrated in the public sector (+200 jobs), with most employment gains taking place within local government (+140 jobs). Within the private sector, private education and health services (+40 jobs), other services (+10 jobs), and information (+10 jobs) were the only major sectors

to gain jobs over the year. Losses were strongest in trade, transportation, and utilities, which lost 70 jobs over the year, followed by mining, logging, and construction (-40 jobs). All other supersectors lost approximately 10 jobs over the year.

Gilliam County's seasonally adjusted unemployment rate was unchanged in March, remaining at 4.6%. Over the year, the seasonally adjusted unemployment rate is 0.5 percentage point lower. Gilliam County's nonfarm employment decreased by 10 jobs (-1.0%) from February to March and is now at 1,005 jobs. Over the year, the private sector gained 180 jobs, while government employment remained unchanged totaling 290 jobs.

Sherman County's seasonally adjusted unemployment rate was unchanged in March at 3.9% and declined by 0.2 percentage point over the year. Sherman County's nonfarm employment increased by 40 jobs (+4.2%) in March and stands at 985. Private-sector employment rose by 15 jobs with growth concentrated within the leisure and hospitality industry (+15 jobs). Public-sector employment growth was stronger and rose by 25 jobs, specifically within local government. Over the year ending in March, private industry lost five jobs and now stands at 630, down by 0.8%.

Wheeler County's seasonally adjusted unemployment rate decreased slightly from a revised rate of 4.4% to 4.3% in March. Over the year, Wheeler County's seasonally adjusted unemployment rate was up by 0.7 percentage point. Total nonfarm employment gained five jobs from February to March and now stands at 375 jobs. Over the year ending in March, private industry employment rose by 10 and was estimated at 185. Government employment declined by five to reach 190. Over the year seasonally adjusted total nonfarm employment is up by 10 jobs.

#### **Next Press Releases**

The Oregon Employment Department plans to release the April county and metropolitan area unemployment rates and employment survey data on Tuesday, May 20, and the statewide unemployment rate and employment survey data for April on Wednesday, May 14.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
