## **Employment in the Columbia Gorge: December 2025**

**Seasonally adjusted unemployment rates declined in two of the five counties while remaining steady in Hood River and increasing in the counties of Wheeler and Gilliam.**

Hood River County's seasonally adjusted unemployment rate was unchanged from November to December and remained at 4.2%. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.7 percentage point.

Hood River County's nonfarm employment increased by 250 (+2.1%) in December and was estimated at 12,330 jobs. Private-sector employment increased over the month (+240 jobs). The largest gains occurred in leisure and hospitality (+330 jobs) with the vast majority taking place in arts, entertainment, and recreation. The largest private-sector losses took place in trade, transportation, and utilities (-40 jobs) and manufacturing (-30 jobs). Public-sector employment gained 10 jobs over the month; all gains recorded at the local level (+10 jobs).

Hood River County's total nonfarm employment decreased by 260 jobs over the year ending in December, representing a 2.1% decrease. Job losses occurred in leisure and hospitality (-240 jobs); trade, transportation, and utilities (-170 jobs); and the public sector (-40 jobs). Losses in leisure and hospitality primarily occurred in arts, entertainment, and recreation (-280 jobs) while losses in trade, transportation, and utilities occurred primarily in retail trade (-200 jobs). Over-the-year gains occurred in manufacturing (+60 jobs); other services (+40 jobs); professional and business services (+30 jobs); financial activities (+30 jobs); private education and health services (+20 jobs); and mining, logging, and construction (+10 jobs).

Wasco County's seasonally adjusted unemployment rate was 5.3% as of December, down from 5.4% in November. Over the year, Wasco County's seasonally adjusted unemployment rate is 1.0 percentage point higher.

Wasco County's nonfarm employment decreased by 0.4%, a decrease of 40 jobs to total 10,260 as of December. Job losses occurred within the private sector (-20 jobs), bringing private employment down to 7,940. Government employment decreased by 20 jobs and is now 2,320. Private job losses were more widespread and larger than gains. Losses were seen in professional and business services (-20 jobs); information (-10 jobs); other services (-10 jobs); and leisure and hospitality (-10 jobs). Private-

sector gains were concentrated in trade, transportation, and utilities (+30 jobs) – the only major sector to see gains.

Wasco County's private industry employment decreased by 110 (-1.1%) jobs over the year ending in December. Losses were strongest in trade, transportation, and utilities (-60 jobs); mining, logging, and construction (-60 jobs); and professional and business services (-50 jobs). Smaller losses also occurred in information (-20 jobs). Over-the-year gains occurred in manufacturing (+40 jobs); financial activities (+20 jobs); leisure and hospitality (+10 jobs); and government (+10 jobs).

Gilliam County's seasonally adjusted unemployment rate increased from November, going from a rate of 5.5% to 5.6% in December. Over the year, the seasonally adjusted unemployment rate is 1.0 percentage point higher.

Gilliam County's nonfarm employment was unchanged from November to December and continued to stand at 935 jobs. Over-the-year total private employment decreased by 105 jobs while government employment increased by 10 jobs for an over-the-year net loss of 95 total nonfarm jobs.

Sherman County's seasonally adjusted unemployment rate decreased from 5.3% in November to 5.2% in December and increased by 1.2 percentage points over the year. Sherman County's nonfarm employment increased by 30 jobs (+3.4%) over the month of December and now stands at 915. Private-sector employment was unchanged over the month, while public-sector employment increased by 30 jobs. Over the year ending in December, private industry shed 35 jobs, bringing the total to 545, a 6.0% decrease from the previous year. Public-sector employment gained five jobs over the year for a net loss of 30 total nonfarm jobs over the year.

Wheeler County's seasonally adjusted unemployment rate increased from 4.7% in November to 4.8% in December. Over the year, Wheeler County's seasonally adjusted unemployment rate was up by 0.8 percentage point. Total nonfarm employment decreased by five jobs (-1.4%) from November to December and now stands at 355 jobs. Over the year ending in December, total nonfarm employment increased by 20 (+6.0%). The private sector added 15 jobs over the year, while the public sector added five.

### **Next Press Releases**

The Oregon Employment Department has yet to receive an updated [release schedule from the Bureau of Labor Statistics](#) (BLS). The January 2026 data would typically be released in March. We are awaiting notification from the BLS regarding publication dates for the rest of the year and will update [our schedule of future releases](#) as dates become available.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
