## **Employment in the Columbia Gorge: September 2025**

### **Seasonally adjusted unemployment rates increase in all five Columbia Gorge Counties**

Hood River County's seasonally adjusted unemployment rate increased from 4.0% in August to 4.1% in September. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.7 percentage point.

Hood River County's nonfarm employment increased by 80 (0.7%) in September and was estimated at 11,930 jobs. Private-sector employment decreased over the month (-230 jobs) with the largest losses occurring in leisure and hospitality (-140 jobs) and retail trade (-60 jobs). Public-sector employment added 310 jobs over the month with most gains recorded in local education (+320 jobs).

Hood River County's total nonfarm employment increased by 50 jobs over the year ending in September, representing a 0.4% increase. Job gains occurred in other services (+40 jobs); private education and health services (+40 jobs); manufacturing (+30 jobs); professional and business services (+20 jobs); and trade, transportation, and utilities (+10 jobs). Over-the-year losses occurred in leisure and hospitality (-40 jobs); information (-20 jobs); government (-20 jobs); and mining, logging, and construction (-10 jobs).

Wasco County's seasonally adjusted unemployment rate was 5.2% as of September, up from 5.0% in August. Over the year, Wasco County's seasonally adjusted unemployment rate increased by 0.9 percentage point.

Wasco County's nonfarm employment increased by 140 jobs to total 10,490 as of September. The private sector dropped 130 jobs, bringing private employment down to 8,140. Government employment increased by 270 jobs and is now 2,350. Private job gains were minimal with no published sectors recording significant gains. Private-sector losses were more widespread but concentrated in leisure and hospitality (-80 jobs) and other services (-20 jobs).

Wasco County's private industry employment decreased by 60 (-0.6%) jobs over the year ending in September. Losses were strongest in trade, transportation, and utilities (-70 jobs) and mining, logging, and construction (-40 jobs). Smaller losses also occurred in other services (-20 jobs), information (-10 jobs), and private education and health services (-10 jobs). Over-the-year gains occurred in

manufacturing (+30 jobs); government (+20 jobs); leisure and hospitality (+20 jobs); professional and business services (+10 jobs); and financial activities (+10 jobs).

Gilliam County's seasonally adjusted unemployment rate increased over the month from 4.8% in August to 5.2% in September. Over the year, the seasonally adjusted unemployment rate increased 0.5 percentage point.

Gilliam County's nonfarm employment gained 20 jobs from August to September and now stands at 950 jobs. All gains occurred within the public sector with little to no movement within the private sector. Over the year, total private employment decreased by 105 jobs while government employment increased by 10 jobs for a net loss of 95 total nonfarm jobs.

Sherman County's seasonally adjusted unemployment rate went from 4.8% in August to 5.0% in September and increased by 1.1 percentage points over the year. Sherman County's nonfarm employment decreased by 15 jobs (-1.6%) over the month of September and now stands at 940. Private-sector employment declined by 20 jobs while public-sector employment gained five jobs. Over the year ending in September, private industry shed 50 jobs, bringing the total to 570, an 8.1% decrease from the previous year. Public-sector employment gained 15 jobs over the year, representing a 4.2% increase.

Wheeler County's seasonally adjusted unemployment rate increased from 3.9% to 4.1% this September. Over the year, Wheeler County's seasonally adjusted unemployment rate was up by 0.2 percentage point. Total nonfarm employment increased by 15 jobs (+4.3%) from August to September and now stands at 360 jobs. Over the year ending in September, private industry employment declined by 25 and was estimated to be 175. Government employment saw no change.

### **Next Press Releases**

The Oregon Employment Department plans to release the next statewide unemployment rate and employment survey data for October and November on Wednesday, Jan. 7 and county and metropolitan area unemployment rates and employment survey data on Tuesday, Jan.13. The October employment survey jobs data will be released along with November's data, but there won't be October labor force or unemployment data published.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
