# **Employment in Eastern Oregon: March 2025**

The March seasonally adjusted unemployment rates held steady over the year in Baker and Harney counties and increased in the other four Eastern Oregon counties. Harney and Wallowa counties' March 2025 rates tie for their second lowest March rates since comparable statistics began in 1990. In Baker County, it ties for the third lowest March rate. The seasonally adjusted rate moved 0.3 percentage point higher in Malheur County to reach 4.3% for the smallest increase. The largest increase came in Grant County where the seasonally adjusted rate rose 1.0 percentage point to reach 6.5%.

Between March 2024 and March 2025, unadjusted unemployment rates increased in all six counties. Baker, Grant, Harney, and Wallowa counties' March 2025 unadjusted rates are their fourth lowest unadjusted March unemployment rates since comparable statistics began in 1990. In Malheur and Union counties, the March 2025 rates are their sixth lowest March rates. Harney County's raw rate rose by 0.1 percentage point to reach 5.8% for the smallest increase. The largest increase came in Wallowa County, where the raw rate increased by 1.5 percentage points to reach 7.5%.

Baker County's nonfarm payroll employment has increased by 90 jobs since March 2024. Employment increased by 10 jobs in the private sector and added 80 jobs in the public sector. Retail trade and local government led gains, up 60 jobs each. Leisure and hospitality led losses, down 60. Total nonfarm employment increased by 40 jobs over the month led by a gain in local government, up 20 jobs. The seasonally adjusted unemployment rate increased by 0.1 percentage point over the month to 4.8%. The raw unemployment rate held steady at 6.0%.

Grant County's nonfarm payroll employment increased by 10 jobs over the year. The private sector added 20 jobs while the public sector decreased by 10. Mining and logging, and state government led gains, each up 20 jobs. Manufacturing and federal government dropped 20 jobs each to lead losses. Over the month, total nonfarm employment increased by 30 led by gains of 10 jobs each in private education and health services, federal government, state government, and local government. Professional and business services was the only industry to lose jobs over the month. The seasonally adjusted unemployment rate held steady over the month at 6.5%. The raw unemployment rate decreased by 0.1 percentage point to 8.8%.

Harney County's nonfarm payroll employment increased by 30 jobs over the year. The private sector added 30 jobs, and the public sector saw a net change of zero jobs. Gains were led by private education and health services, up 30 jobs. Losses were led by retail trade, down 20 jobs. Total nonfarm

employment increased by 50 jobs over the month, led by a gain of 20 jobs in professional and business services. The seasonally adjusted unemployment rate held steady over the month at 4.5%. The raw unemployment rate fell by 0.4 percentage point to 5.8%.

Malheur County's nonfarm payroll employment increased by 50 jobs over the year. The private sector fell by 40, and the public sector added 90 jobs. Manufacturing added 100 jobs to lead gains, followed by a gain of 80 jobs in local government. Leisure and hospitality dropped 50 jobs to lead losses, followed by mining, logging, and construction, down 40. Total nonfarm employment increased by 140 jobs over the month, led by a gain of 60 jobs in local government. Wholesale trade led losses, down 20. The seasonally adjusted unemployment rate rose by 0.1 percentage point over the month to 4.3%. The raw unemployment rate held steady at 5.0%.

Union County's nonfarm payroll employment decreased by 10 jobs over the year. The private sector dropped 110 jobs, and the public sector increased by 100 jobs. Local government led gains, up 90 jobs, followed by private education and health services, up 60. Manufacturing dropped 60 jobs to lead losses, followed by construction, and professional and business services, down 40 jobs each. Total nonfarm employment increased by 70 jobs over the month, with federal government leading gains, up 30. The seasonally adjusted unemployment rate increased by 0.2 percentage point over the month to 5.2%. The raw unemployment rate fell by 0.1 percentage point to 6.5%.

Wallowa County's nonfarm payroll employment decreased by 30 jobs from March 2024 to March 2025. The private sector dropped 60 jobs, and the public sector increased by 30. Manufacturing led losses, down 20 jobs. State government and local government led gains, up 20 jobs each. Total nonfarm employment increased by 10 jobs over the month with small gains in wholesale and retail trade, and leisure and hospitality overcoming a small loss in mining and logging. The seasonally adjusted unemployment rate rose by 0.1 percentage point over the month to 4.9%. The raw unemployment rate increased by 0.2 percentage point to 7.5%.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
