Employment in Lane County (Eugene MSA)

Lane County Employers Drop 800 Jobs in March

Lane County's seasonally adjusted payroll employment declined by 800 jobs in March after a gain of 300 in February and a gain of 100 in January.

In the not seasonally adjusted private-sector industries in March, there were relatively large losses in private education and health services (-300) and professional and business services (-200). There were gains of 100 each in leisure and hospitality, and other services.

Government rose 100 jobs in March from an increase of 100 in local education.

When comparing March 2025 with March 2024, total nonfarm employment added 1,000 jobs on a seasonally adjusted basis for a gain of 0.6%. There were large over-the-year gains in private education and health services (900), professional and business services (400), and other services (200). There were relatively large losses in construction (-400), manufacturing (-400), retail trade (-400), and leisure and hospitality (-300).

There was an over-the-year increase of 1,200 in government due to gains in local education, which includes the University of Oregon (900), state government (200), and noneducation local government (100).

Labor force statistics for Oregon metropolitan statistical areas (MSAs) are produced by the U.S. Department of Labor, Bureau of Labor Statistics. Through June 2025, seasonally adjusted data are not available for Oregon MSAs or other MSAs around the country. New MSA definitions resulting from the 2020 Census are being incorporated into the history of the data series back to 1990, as well as other updates to the processing of labor force estimates for substate areas. Read more on this pause in seasonally adjusted metro area data here. The not seasonally adjusted rate was essentially unchanged at 5.0% in March compared to 5.1% in February. The unadjusted rate is up from 4.4% in March 2024 to 5.0% in March 2025.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family w orkers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
