Employment in Lincoln County: May 2025

Seasonally adjusted employment decreased by 30 jobs in May

Seasonally adjusted nonfarm payroll employment decreased by 30 in May to 18,580 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 260 jobs was expected for the month. The county's total nonfarm employment actually increased by 230, with a gain of 240 jobs in the private sector, and government employment decreased by 10. Leisure and hospitality added 130 jobs. Manufacturing added 40 jobs. Indian tribal employment, a component of local government, decreased by 20.

May's total nonfarm employment numbers were down by 70 jobs over the year, a decrease of 0.4%. The largest gains occurred in private education and health services which rose by 80 jobs over the year in May. Food services and drinking places lost 110 jobs. Local government, excluding tribal and education, added 60 jobs.

Lincoln County's seasonally adjusted unemployment rate was 5.3% in May, up from 5.2% in April. It edged up from 5.0% the year before. The statewide unemployment rate was 4.8% in May, and the national rate was 4.2%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
