Employment in Albany MSA (Linn County): December 2025

Linn County's Unemployment Rate Remains at 5.6%

Linn County's seasonally adjusted unemployment rate was 5.6% in December, matching November's revised unemployment rate. Linn County's unemployment rate has increased from 4.7% to 5.6% over the past year. Oregon's statewide unadjusted unemployment rate in December was 5.2%.

Linn County's employment losses in December were larger than normal; total nonfarm employment decreased by 290 jobs, when employment would be expected to decrease 110. As a result, seasonally adjusted employment was down 180 between November and December. Employment is now 0.9%, or 400 jobs, above the pre-pandemic employment level in February 2020.

Linn County's seasonally adjusted total nonfarm employment was down 670 (-1.4%) over the past year.

Private-sector employment was down 180 in December. Construction (-130 jobs, -3.9%) had the largest employment losses in December. Transportation, warehousing, and utilities employment dropped 40 jobs or -1.2%.

Public-sector employment lost 110 jobs in December. Local government employment decreased 110. State and federal government employment were both unchanged.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
