Employment in Salem MSA (Marion and Polk Counties): June 2025

Salem MSA's Unemployment Rate Increased to 4.6%

The Salem MSA's seasonally adjusted unemployment rate was 4.6% in June, up from its May rate of 4.5%. Oregon's statewide unemployment rate in June was 4.9%, up from its May rate of 4.8%.

Employment losses in the Salem MSA in June were slightly more than normal; total nonfarm employment decreased by 1,400 jobs, when an employment decrease of 1,200 jobs would be expected. As a result, seasonally adjusted employment was down 200 between May and June. With June's losses, employment is up 7.5% or 13,100 jobs above the pre-pandemic employment level in February 2020.

Overall, the private sector lost 1,800 jobs in June. The largest private-sector job gains in June were reported in leisure and hospitality (+300 jobs, +1.8%). Private education and health services lost 2,100 jobs (-5.4%) in June.

The public sector added 200 jobs in June. Local government was up 200 jobs in June. State and federal government employment were unchanged.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
