

Employment in South Central Oregon: April 2025

The seasonally adjusted unemployment rate continued to rise in Klamath County over the month of April but remained unchanged in Lake County.

Klamath County: The seasonally adjusted unemployment rate continued to increase slightly in April and is now 6.4%, up from a rate of 6.3% in March. In April 2024 the unemployment rate was lower at 5.8%.

Klamath County gained 190 jobs (+0.8%) in April, with the majority of gains taking place within leisure and hospitality (+130 jobs). Notable job growth also occurred in mining, logging, and construction (+50 jobs), specifically in construction (+50 jobs); professional and business services (+40 jobs); the public sector (+20 jobs); and other services (+10 jobs). Employment losses were seen in private education and health services (-40 jobs) and in trade, transportation, and utilities (-20 jobs), while all



other supersectors saw little to no change over the month of April.

Klamath County gained 30 jobs in the past year (+0.1%) with private-sector gains concentrated in financial activities (+60 jobs); leisure and hospitality (+50 jobs); manufacturing (+40 jobs); and other services (+40 jobs). While public-sector employment grew overall throughout the year, adding 30 jobs, federal employment declined by 20. Notable private-sector job losses over the past year were also seen in construction (-100 jobs); trade, transportation, and utilities (-50 jobs); professional and business services (-30 jobs); and information (-10 jobs). All other industries saw little to no change over the year.

Lake County: The seasonally adjusted unemployment rate was unchanged over the month of March at 5.4% – last April it was 4.9%. The unemployment rate was 4.2% in February 2020, before the impacts of COVID-19 were first felt.

Total nonfarm employment was little changed from March to April with an increase of 20 jobs over the month. Marginal gains were seen across manufacturing; other services; and trade, transportation, and utilities, with each sector adding 10 jobs over the month. The only supersector losing jobs over the month was the public sector (-10 jobs). All other industries saw little to no gains over the month. Seasonally adjusted total nonfarm employment levels remain 320 jobs (-13.4%) below the prepandemic March 2020 employment levels, as of April.

Lake County's total nonfarm employment has declined by 170 jobs (-7.6%) since April 2024. Over the year, supersector losses were primarily concentrated within the public sector (-80 jobs) but were also more widespread. Smaller yet noticeable declines occurred in leisure and hospitality; professional and business services; manufacturing; and mining, logging, and construction, with each losing 20 jobs over the year. Similarly, private education and health services lost 10 jobs over the year. While no supersector saw overall gains year-over-year, both retail trade and state government experienced an employment increase of 10 jobs.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
