

## **Employment in South Central Oregon: June 2025**

Seasonally adjusted unemployment rates continued to increase in both South Central counties this June, with a slightly larger percentage point increase in Lake County.

**Klamath County:** The seasonally adjusted unemployment rate continued to increase over the month of June and is now 6.7%, up from a rate of 6.5% in May. In June 2024, the unemployment rate was 0.8 percentage point lower, at 5.9%.

Klamath County added 60 jobs in June, a +0.2% increase, with the largest gains occurring within leisure and hospitality (+140 jobs); construction (+40 jobs); and government (+30 jobs). Losses were slightly more widespread but not as large taking place within private education and health services (-40 jobs); manufacturing (-40 jobs); trade, transportation, and utilities (-40 jobs); and professional and business services (-30 jobs). All other



industries saw little to no change. As a result, total nonfarm employment for the month is now 24,070.

Klamath County lost 140 jobs in the past year (-0.6%) with private-sector losses concentrated in construction (-110 jobs); professional and business services (-80 jobs); trade, transportation, and utilities (-70 jobs); and private education and health services (-70 jobs). Information also lost 10 jobs over the year. While total public-sector employment grew throughout the year, adding 30 jobs, federal employment declined by 40 and local government employment by 10. Notable private-sector job gains occurred in leisure and hospitality (+110 jobs); other services (+40 jobs); and financial activities (+20 jobs), while all other industries saw little to no change over the year.

<u>Lake County</u>: The seasonally adjusted unemployment rate increased over the month, going from 5.8% in May to 6.1% in June – last year around this time it was 1.2 percentage points lower, at 4.9%. The unemployment rate was 4.2% in February 2020, before the impacts of COVID-19 were first felt.

Total nonfarm employment was little changed from May to June with an increase of 40 jobs over the month (+1.9%). Small gains were seen within other services (+20 jobs); mining, logging, and construction (+10 jobs); and government (+10 jobs). All other major industries saw little to no movement over the month. Seasonally adjusted total nonfarm employment levels are 340 jobs (-14.2%) below the pre-pandemic May 2020 employment levels, as of June.

Lake County's total nonfarm employment has declined by 200 jobs (-8.5%) since June 2024. Over the year, supersector losses were primarily concentrated within the public sector (-130 jobs) but were also more widespread. Smaller yet noticeable declines occurred in leisure and hospitality (-30 jobs); private education and health services (-20 jobs); and manufacturing (-20 jobs). Similarly, professional and business services; financial activities; and construction lost 10 jobs. The only industries to gain jobs over the year ending in June were other services (+20 jobs) and trade, transportation, and utilities (+10 jobs). While public-sector employment is down 11.3% over the year ending in June 2025, losses were concentrated within local government employment (-140 jobs).

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
