Employment in South Coast: June 2025 South Coast Payroll Employment Down Slightly Over the Year

Coos County total payroll employment was unchanged in June. Leisure and hospitality added 60 jobs, the only industry with a notable job increase. Employment fell over the month in transportation, warehousing, and utilities (-60), and private education and health services (-50). Government employment rose by 30 jobs in June. Indian tribal local government (+20) and state government (+10) showed gains over the month.

Since June 2024, Coos County payroll employment fell by 210 jobs, a decline of 0.9%. Employment gains occurred in manufacturing (+50); leisure and hospitality (+50); wholesale trade (+30); and other services (+20). Professional and business services (-170); transportation, warehousing, and utilities (-140); construction (-50); and private education and health services (-30) lost jobs over the year. Government employment was up by 40 jobs with losses in local government excluding education and tribal (-50) offset by gains in Indian tribal (+60) and local government education (+30).

Curry County payroll employment rose by 100 jobs in June. Leisure and hospitality employment rose by 70 jobs. Trade, transportation, and utilities added 30 jobs over the month. Government employment increased by 10, all in state government.

Over the past year, Curry County payroll employment climbed by 50 jobs for an increase of 0.7%. Losses were estimated in professional and business services (-40); and financial activities (-20). However, the county saw employment rise in private education and health services (+30), leisure and hospitality (+20), and manufacturing (+20).

The Oregon Employment Department plans to release the July county and metropolitan area unemployment rates and employment survey data on Tuesday, Aug. 19th, and the statewide unemployment rate and employment survey data for July on Wednesday, Aug 13th.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
