Employment in South Coast: September 2025

Coos County Payroll Employment Rises Over the Year

Coos County total payroll employment rose by 20 jobs in September. Industries with estimated job gains over the month were private education and health services (+60); and transportation, warehousing, and utilities (+30). Job losses were estimated in leisure and hospitality (-30); construction (-20); mining and logging (-20); retail trade (-20); and professional and business services (-20). Government employment increased by 60 jobs in September with a gain in local government education (+90) offset by job losses in Indian tribal (-20); and local government excluding education and tribal (-10).

Since September 2024, Coos County payroll employment rose by 270 jobs, a gain of 1.2%. Employment gains occurred in leisure and hospitality (+90); private education and health services (+70); retail trade (+60); manufacturing (+60); and construction (+30). Government employment was up by 70 jobs. A loss of 40 jobs in local government excluding education and tribal was offset by gains in Indian tribal (+90), local education (+10), and state government (+30).

Curry County payroll employment increased by 60 jobs in September, mostly due to a seasonally expected increase of 70 jobs in local government education. Leisure and hospitality employment fell by 30 jobs. Private education and health services employment increased by 20 jobs.

Over the past year, Curry County payroll employment climbed by 140 jobs for an increase of 2.0%. Job gains were estimated in private education and health services (+70); financial activities (+60); manufacturing (+50); and leisure and hospitality (+30).

Next Press Releases

The Oregon Employment Department plans to release the October and November county and metropolitan area unemployment rates and employment survey data on Tuesday, Jan. 13th, and the statewide data for October and November on Wednesday, Jan. 7th. The October employment survey jobs data will be released along with November's data, but there won't be October labor force or unemployment data published.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
