Employment in Yamhill County: November 2025

Yamhill County's Unemployment Rate is 5.0%

Yamhill County's seasonally adjusted unemployment rate was 5.0% in November, unemployment rates for October are unavailable at this time. Yamhill County's unemployment rate increased from 4.0% to 5.0% over the past year. Oregon's statewide unemployment rate in November was 5.2%. Oregon's unemployment rate increased from 4.3% to 5.2% over the past year.

Yamhill County's employment losses in November were less than normal; total nonfarm employment decreased 200 jobs, when an employment decrease of 300 jobs would be expected. As a result, seasonally adjusted employment was up 100 in November. Employment is 1,800 jobs (+5.1%) above the pre-pandemic level in February 2020.

The private sector shed 260 jobs in November. The largest private-sector industry employment losses in November were reported in manufacturing (-130 jobs, -1.9%) and construction (-80 jobs, -3.6%).

Yamhill County's public-sector employment was up 60 in November. Local government employment was up 70 jobs. Federal government employment was down 10. State government employment was unchanged in November.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
