Employment in Clatsop County: December 2023

Seasonally adjusted employment decreased by 80 in December

Seasonally adjusted nonfarm payroll employment decreased by 80 in December to 19,140 jobs. Seasonally adjusted figures compare expected changes with actual changes. A decrease of 280 jobs was expected for the month, and the county lost 360 jobs. The private sector lost 300 jobs, and total government employment decreased by 60. Leisure and hospitality lost 190 jobs. Construction lost 30 jobs. Local government lost 50 jobs.

December's total nonfarm employment was up from the previous year by 490 jobs, an increase of 2.7%. Some major industries gained jobs over the past year, but others have plateaued or shed a few. Nondurable goods manufacturing gained 150 jobs. Private education and health services added 140 jobs. Professional and business services dropped 70 jobs. Local education added 20 jobs.

Clatsop County's seasonally adjusted unemployment rate was 3.7% in December. It was essentially unchanged from 3.6% in November. The rate was 4.8% the year before. The statewide unemployment rate was 3.7% in December, and the national rate was 3.7%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
