## **Employment in Morrow & Umatilla Counties: December 2023**

### **Unemployment Rates Hold Steady in December**

Umatilla County's seasonally adjusted unemployment rate held steady at 3.8% in December. Ranked among Oregon's 36 counties, Umatilla County placed 16<sup>th</sup>, tied with Union. Over the year, Umatilla County's seasonally adjusted unemployment rate fell by 1.4 percentage points.

Umatilla County's nonfarm employment total fell to 30,260 in December, a loss of 190 jobs. Private industry cut 120 jobs in December, falling to 22,430, and government shed 70, dropping to 7,830. Mining, logging, and construction pulled back in December, falling to 1,390, a loss of 60. Manufacturing cut 30 jobs, falling to 2,480, while education and health services shed 20. Private jobs gains were limited to an increase of 10 in leisure and hospitality. In the public sector, local education cut 60 jobs, falling to 2,750, federal government cut 20 and state government lost 20. Indian tribal provided a partially offsetting increase of 30, rising to 1,870 jobs.

Umatilla County's total private industry employment rose by 620 jobs over the year ending in December (+2.8%). Manufacturing cut 160 jobs over the year and transportation, warehousing, and utilities lost 40 (-1.6%). Professional and business services led private-industry growth, rising by 360 jobs thanks in part to a non-economic code change (a correction or reclassification in our administrative records). Education and health services increased its total by 120 jobs (+3.0%) and leisure and hospitality rose by 100 (+3.5%). Government employment increased by 190 jobs over the year, led by a gain of 100 in state government. Indian tribal rose by 70 jobs, other local increased its total by 80, and local education cut 70.

Morrow County's seasonally adjusted unemployment rate held steady in December at 3.4%, ranking sixth among Oregon counties, tied with Yamhill. Over the year, Morrow County's seasonally adjusted unemployment rate fell by 1.2 percentage points.

Morrow County's nonfarm employment fell to 5,780 in December, a loss of 20 jobs. Private industry cut its total to 4,640 in December, a loss of 10, while government also idled 10, falling to 1,140. Manufacturing rose by 10 jobs in December to reach 1,910. Education and health services also rose by 10, climbing to 300. Mining and logging (-10); construction (-10); and professional and business services (-10) cut jobs in December. In the public sector, federal government cut 10 jobs, while state and local held steady.

Morrow County's private-industry employment rose by 150 jobs over the year ending in December (+3.6%). Manufacturing (+50), professional and business services (+40), and leisure and hospitality (+40) led private industry's over-the-year growth. Local government rose by 70 jobs over the year, while state and federal government each cut 10.

### Next Press Releases

The Oregon Employment Department plans to release the January 2024 Oregon, county and metropolitan area unemployment rates on March 5<sup>th</sup>, 2024.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
