# Employment in the Columbia Gorge: December 2022 Unemployment Rates Rise over Five Month Period Ending in December

In December, Hood River County's seasonally adjusted unemployment rate rose by 0.2 percentage point to 3.6%. Hood River County's unemployment rate ranked as Oregon's fourth lowest, tied with Benton. Over the year, the county's seasonally adjusted unemployment rate fell by 0.1 percentage point.

Hood River County's nonfarm employment rose by 260 jobs to 12,650 in December. Private industry rose by 280 jobs to 11,290 and government cut 20, falling to 1,360. Arts, entertainment, and recreation led private industry, adding 370 jobs to reach 1,100. Education and health services chipped in 20 jobs, rising to 1,900. Retail trade cut 40 jobs, falling to 1,720, and wholesale trade shed 30, dropping to 550. Manufacturing (-20 jobs) and food services and drinking places (-20) also cut jobs in December.

Hood River County's private industry employment rose by 2.5% over the year, adding 290 jobs. Arts, entertainment, and recreation led private industry, rising by 130 jobs over the year. Other industries adding jobs included other services (+50), manufacturing (+40), and food services and drinking places (+30).

Wasco County's seasonally adjusted unemployment rate rose by 0.2 percentage point to 4.2% in December, low enough to rank ninth, tied with Morrow and Multnomah. Over the year, Wasco County's seasonally adjusted unemployment rate fell by 0.3 percentage point.

Wasco County's nonfarm employment fell by 50 jobs in December, dropping to 10,150. Private industry cut 30 jobs in December, falling to 8,140, and government shed 20, dropping to 2,010. Information led private industry, rising by 40 jobs to reach 350. Leisure and hospitality cut 20 jobs in December, dropping its total to 1,180. Federal government and state government each cut 10 jobs in December. Wasco County remains about 140 jobs or 1.4% shy of its pre-pandemic high.

Wasco County's private-industry employment fell by 10 jobs or 0.1% over the year ending in December. Accommodation and food services (+3.6%) joined professional and business services (+5.3%) and other services (+8.3%), increasing payrolls by 40 jobs each. Retail trade rose by 30 jobs to reach 1,640 (+1.9%). Education and health services cut 130 jobs, an over-the-year loss of 5.6%. In the public sector, local education rose by 30 jobs over the year (+3.9%).

Gilliam County's seasonally adjusted unemployment rate rose by 0.1 percentage point in December to 4.1%, ranking eighth out of 36 Oregon counties. Over the year, Gilliam County's seasonally adjusted unemployment rate rose by 0.2 percentage point. Gilliam County's nonfarm employment rose to 795 in December, an increase of 10. Over the year, Gilliam County's private industry total fell by 130 jobs to 555, a loss of 19%, and government held its own with 240.

Sherman County's seasonally adjusted unemployment rate rose by 0.2 percentage point in December to 3.4%, ranking second in Oregon, just ahead of Washington County. Over the year, Sherman County's seasonally adjusted unemployment rate fell by 0.4 percentage point. Sherman County's nonfarm employment rose by 10 jobs in December, climbing to 915. Over the year ending in December, private industry rose by 35 jobs to 610 (+6.1%) and government held its own with 305.

Wheeler County's seasonally adjusted unemployment rate rose to 3.2% in December, ranking as Oregon's lowest county unemployment rate. Over the year, Wheeler County's seasonally adjusted unemployment rate rose by 0.2 percentage point. Nonfarm employment totaled 300 in December, with private industry cutting five jobs and government losing 10. Over the year ending in December, private industry rose to 165 (+10) and government dropped to 135 (-5).

#### **Next Press Releases**

The Oregon Employment Department plans to release the January 2023 county and metropolitan area unemployment rates and statewide unemployment rate and employment survey data on March  $7^{th}$ , 2023.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
