# Employment in the Columbia Gorge: January 2023 Unemployment Rates Rise Above Year-Ago Levels

In January, Hood River County's seasonally adjusted unemployment rate rose by 0.1 percentage point to 3.7%. Hood River County's unemployment rate ranked as Oregon's fourth lowest, tied with Benton. Over the year, the county's seasonally adjusted unemployment rate rose by 0.2 percentage point.

Hood River County's nonfarm employment fell by 410 jobs to 12,260 in January. Private industry cut 400 jobs, falling to 10,890, and government idled 10, dropping to 1,370. Wholesale trade led private industry, adding 90 jobs to reach 500. Arts, entertainment, and recreation rose by 70 jobs to total 1,180. Education and health services chipped in 10 jobs, rising to 1,960. Retail trade cut 340 jobs in January, falling to 1,400, and accommodation and food services shed 100, dropping to 1,530. Mining, logging, and construction (-40 jobs) and manufacturing (-40) also cut jobs in January.

Hood River County's private industry employment rose by 3.9% over the year, adding 410 jobs. Leisure and hospitality led private industry, rising by 160 jobs (6.3%). Other industries adding jobs included retail trade (+70); education and health services (+70); other services (+70); manufacturing (+60); and mining, logging, and construction (+40).

Wasco County's seasonally adjusted unemployment rate rose by 0.1 percentage point to 4.3% in January, low enough to rank  $10^{\rm th}$ , tied with Morrow. Over the year, Wasco County's seasonally adjusted unemployment rate fell by 0.1 percentage point.

Wasco County's nonfarm employment fell by 100 jobs in January, dropping to 10,080. Private industry lost 100 jobs, falling to 8,060, and government held steady at 2,020. Leisure and hospitality cut 40 jobs in January, dropping its total to 1,160, and transportation, warehousing, and utilities shed 30, falling to 330. Local government education rose by 10 jobs in January to reach 800 and state government cut 10, dropping to 250. Wasco County remains about 140 jobs or 1.4% shy of its pre-pandemic high.

Wasco County's private-industry employment rose by 160 jobs or 2.0% over the year ending in January. Other services led private industry, rising by 70 jobs or 20.6% over the 12-month period ending in January. Information rose by 60 jobs to reach 320 (+23.1%) and leisure and hospitality chipped in 40. Job losses in manufacturing (-30), professional and business services (-30), and

education and health services (-30) moderated private industry's over-the-year performance. Local education led the public sector, rising by 90 jobs, and other local government chipped in 30.

Gilliam County's seasonally adjusted unemployment rate rose by 0.1 percentage point in January to 4.0%, ranking seventh out of 36 Oregon counties. Over the year, Gilliam County's seasonally adjusted unemployment rate rose by 0.2 percentage point. Gilliam County's nonfarm employment fell to 955 in January, a loss of 25. Over the year, Gilliam County's private industry employment rose by 120 jobs to 725, an increase of nearly 20%, while government cut five, falling to 230.

Sherman County's seasonally adjusted unemployment rate fell by 0.1 percentage point in January to 3.5%, ranking second in Oregon, just ahead of Washington County. Over the year, Sherman County's seasonally adjusted unemployment rate fell by 0.3 percentage point. Sherman County's nonfarm employment fell by 20 jobs in January, dropping to 920. Over the year ending in January, private industry rose by 50 jobs to 625 (+8.7%) and government chipped in five to reach 295.

Wheeler County's seasonally adjusted unemployment rate held steady at 3.2% in January, ranking as Oregon's lowest county unemployment rate. Over the year, Wheeler County's seasonally adjusted unemployment rate rose by 0.2 percentage point. Nonfarm employment totaled 305 in January, with private industry cutting 10 jobs and government holding its own. Over the year ending in January, private industry rose to 165 (+20) and government was unchanged at 140 jobs.

#### **Next Press Releases**

The Oregon Employment Department plans to release the February 2023 county and metropolitan area unemployment rates on March 28<sup>th</sup>, 2023 and the statewide unemployment rate and employment survey data on March 21<sup>st</sup>, 2023.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
