# Employment in the Columbia Gorge: December 2023 December Snowfall Arrives Late and Unemployment Rates Little Changed

In December, Hood River County's seasonally adjusted unemployment rate rose by 0.1 percentage point to 3.0%. Hood River County's unemployment rate ranked as Oregon's second lowest, trailing Wheeler but just ahead of Benton's 3.2%. Over the year, the county's seasonally adjusted unemployment rate fell by 1.2 percentage points.

Hood River County's nonfarm employment fell by 230 jobs in December to 12,390. Private industry cut 230 jobs, falling to 10,880 jobs, and government held steady with 1,510. Arts, entertainment, and recreation suffered from a lack of snowfall, cutting 160 jobs to total 510. Wholesale trade cut 40 jobs, falling to 470, and retail trade idled 20. In the public sector, federal government cut 10 jobs and local government added back 10.

Hood River County's private-industry employment fell by 80 jobs over the year ending in December, a loss of 0.7%. Education and health services led private industry with an over-the-year increase of 90 jobs, rising to 1,990. Wholesale trade (+60); mining, logging, and construction (+50); retail trade (+50); food services and drinking places (+50); other services (+50); and manufacturing (+40) also rose over the year. Local government education rose by 30 jobs over the year and state government chipped in 10.

Wasco County's seasonally adjusted unemployment rate held steady in December at 3.7%, ranking  $11^{th}$  tied with Clatsop, Marion, and Polk. Over the year, Wasco County's seasonally adjusted unemployment rate fell by 1.1 percentage points.

Wasco County's nonfarm employment fell to 10,460 in December, a loss of 10 jobs. Private industry cut 30 jobs, falling to 8,270, while government rose to 2,190, an increase of 20. Leisure and hospitality cut 20 jobs in December, falling to 1,340. Mining and logging (-10); construction (-10); manufacturing (-10); and other services (-10) also cut jobs. Private-industry job gains were limited to transportation, warehousing, and utilities (+20) and retail trade (+10). In the public sector, local education rose by 30 jobs and state government cut 10.

Wasco County's private-industry employment rose by 290 jobs over the year ending in December. Leisure and hospitality led private industry, rising by 110 jobs (+8.9%). Professional and business

services rose by 90 jobs to reach 600. Education and health services rose to 2,270, an increase of 60. Construction cut 30 jobs over the year ending in December, falling to 390. Local government led the public sector, with other local up 70 jobs and local education rising by 50. State government also rose over the year, adding 10 jobs to reach 270.

Gilliam County's seasonally adjusted unemployment rate rose by 0.2 percentage point in December to 4.6%, ranking 31<sup>st</sup> out of 36 Oregon counties. Gilliam County's seasonally adjusted unemployment rate rose by 0.7 percentage point over the year ending in December. Gilliam County's nonfarm employment held steady in December with 850 jobs. Over the year, the private sector lost 270 jobs (-30.6%), while government cut five, falling to 250.

Sherman County's seasonally adjusted unemployment rate fell by 0.1 percentage point in December to 4.0%, ranking 19<sup>th</sup>. Over the year, Sherman County's seasonally adjusted unemployment rate rose by 0.4 percentage point. Sherman County's nonfarm employment rose by 20 jobs in December, to reach 960. Over the year ending in December, private industry cut five jobs, falling to 635, and government increased its total by 10 to reach 325.

Wheeler County's seasonally adjusted unemployment rate fell by 0.1 percentage point in December to 2.7%, ranking as Oregon's lowest. Over the year, Wheeler County's seasonally adjusted unemployment rate fell by 0.8 percentage point. Nonfarm employment fell to 355 jobs in December, a loss of 10. Over the year ending in December, private industry cut five jobs, falling to 170, and government rose by 45 to reach 185.

### **Next Press Releases**

The Oregon Employment Department plans to release the January 2024 Oregon, county and metropolitan area unemployment rates on March 5th, 2024.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
