Employment in the Columbia Gorge: January 2024

Winter Snowfall Finally Arrives and Unemployment Rates Little Changed

In January, Hood River County's seasonally adjusted unemployment rate rose by 0.1 percentage point to 3.1%. Hood River County's unemployment rate ranked as Oregon's second lowest, trailing Wheeler but just ahead of Benton's 3.3%. Over the year, the county's seasonally adjusted unemployment rate fell by 1.0 percentage point.

Hood River County's nonfarm employment fell by 190 jobs in January to 12,200. Private industry cut 160 jobs, falling to 10,720 jobs, and government fell by 30 jobs to a total of 1,480. The arts, entertainment, and recreation sector finally received welcome snowfall and added 670 jobs to total 1,180. Retail trade lost 460 jobs. Additional declines were estimated in accommodation and food services (-120); manufacturing (-100); and mining, logging, and construction (-60).

Hood River County's private-industry employment grew by 80 jobs over the year ending in January, a gain of 0.8%. Private education and health services led private industry with an over-the-year increase of 80 jobs, rising to 2,020. Wholesale trade (+60), accommodation and food services (+40), and manufacturing (+20) also rose over the year. Local government education rose by 40 jobs over the year and federal government added 20.

Wasco County's seasonally adjusted unemployment rate edged lower in January to 3.8%, ranking eighth tied with Tillamook, Marion, and Umatilla. Over the year, Wasco County's seasonally adjusted unemployment rate fell by 1.1 percentage points.

Wasco County's nonfarm employment fell to 10,150 in January, a loss of 310 jobs. Private industry cut 270 jobs, falling to 8,000, while government dipped to 2,150, a decrease of 40. Leisure and hospitality shed 100 jobs in January, falling to 1,240. Transportation, warehousing, and utilities (-50); retail trade (-40); construction (-20); manufacturing (-20); and private education and health services (-20) also cut jobs. Private-industry job gains were limited to information (+20). In the public sector, local education fell by 40 jobs and local government excluding education and tribal cut 20.

Wasco County's private-industry employment rose by 20 jobs over the year ending in January. Gains were estimated in other services (+40); leisure and hospitality (+30); and manufacturing (+30). Professional and business services rose by 20 jobs to reach 580. Industries losing jobs were retail trade

(-40); transportation, warehousing, and utilities (-40); and private education and health services (-20). Construction cut 20 jobs over the year, falling to 370. Local government led the public sector, with other local up 30 jobs, but local education was unchanged over the year. State government also rose over the year, adding 20 jobs to reach 290.

Gilliam County's seasonally adjusted unemployment rate rose by 0.3 percentage point in January to 4.9%, ranking 32nd highest out of 36 Oregon counties. Gilliam County's seasonally adjusted unemployment rate rose by 1.1 percentage points over the year ending in January. Gilliam County's nonfarm employment was little changed in January with 865 jobs. Over the year, the private sector lost 130 jobs (-17.7%), while government cut 15, falling to 260.

Sherman County's seasonally adjusted unemployment rate edged up by 0.1 percentage point in January to 4.1%. Over the year, Sherman County's seasonally adjusted unemployment rate rose by 0.4 percentage point. Sherman County's nonfarm employment fell by 30 jobs in January, to reach 930. Over the year ending in January, private industry cut five jobs, falling to 620, and government increased its total by 20 to reach 310.

Wheeler County's seasonally adjusted unemployment rate rose by 0.1 percentage point in January to 2.8%, ranking as Oregon's lowest. Over the year, Wheeler County's seasonally adjusted unemployment rate fell by 0.8 percentage point. Nonfarm employment fell to 345 jobs in January, a loss of 10. Over the year ending in January, private industry cut five jobs, falling to 165, and government rose by five to reach 180.

Next Press Releases

The Oregon Employment Department plans to release the February county and metropolitan area unemployment rates and employment survey data on Tuesday, March 26th, and the statewide unemployment rate and employment survey data for February on Wednesday, March 20th.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
