## **Employment in Lane County (Eugene MSA)**

## Lane County's Payroll Employment Decreases by 200 Jobs in March

Lane County's seasonally adjusted payroll employment decreased by 200 jobs in March after a gain of 900 in February and a loss of 1,800 in January.

In the not seasonally adjusted private-sector industries in March, there were relatively large gains in private education and health services (200), and leisure and hospitality (200). There was a small loss in construction (-100).

Government added 100 jobs in March due to a gain of 100 in noneducation local government.


When comparing March 2024 with March 2023, total nonfarm employment was unchanged on a seasonally adjusted basis. There was an over-the-year gain in private education and health services (1,600). There were large losses in retail trade (-1,300), leisure and hospitality (-900), and professional and business services (-700).

There was an over-the-year increase of 1,700 in government due to gains in local education (1,100), noneducation local government (400), federal government (100), and state government (100).

Lane County's seasonally adjusted unemployment rate was unchanged at 4.4% in March compared with a revised 4.4% in February. The rate is lower than the 4.8% recorded in March 2023. Lane County's record low rate was 3.5% in December 2019. The Oregon seasonally adjusted March rate was 4.2% and the U.S. rate was 3.8%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
