Employment in Lincoln County: April 2024

Seasonally adjusted employment decreased by 210 in April

Seasonally adjusted nonfarm payroll employment decreased by 210 in April to 18,500 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 420 jobs was expected for the month, but the county's total nonfarm employment increased by 210. The private sector gained 210 jobs. Leisure and hospitality added 110 jobs. Financial activities added 30 jobs. Local education decreased by 20.

April's total nonfarm employment numbers were essentially unchanged from one year before with a gain of 20 jobs. Private education and health services was up 20 jobs over the year in April. Leisure and hospitality shed 120 jobs over the year. Local government, including tribal and education, added 160 jobs over the past year.

Lincoln County's seasonally adjusted unemployment rate was 4.6% in April, unchanged from a revised 4.6% in March. It was 4.2% the year before. The statewide unemployment rate was 4.2% in April, and the national rate was 3.9%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
