Employment in Albany MSA (Linn County): December 2022

Linn County's Unemployment Rate Increases to 4.8%

Linn County's seasonally adjusted unemployment rate was 4.8% in December, up from its revised rate of 4.6% in November. Oregon's statewide unemployment rate in December was 4.5%, up from its revised November rate of 4.3%.

Linn County's employment losses in December were less than normal; total nonfarm employment decreased by 10 jobs, when employment would be expected to decline 130. As a result, seasonally adjusted employment increased by 120 jobs between November and December. Employment is now 2.3%, or 1,080 jobs, above the pre-pandemic employment level in February 2020.

The private sector added 120 jobs in December. Industries showing the largest employment gains in December included trade, transportation, and utilities (+120 jobs, +1.0%); manufacturing (+40 jobs, +0.5%); and leisure and hospitality (+20 jobs, +0.5%).

Construction shed 40 jobs in December.

Public-sector employment was down 130 jobs in December. Local government employment shed 110. Federal government and state government each dropped 10 jobs in December.

The most recent month is preliminary, the prior month is revised. Prepared in cooperation with the U.S. Department of Labor, Bureau of Labor Statistics.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Offical Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
