Employment in Tillamook County: March 2023

Seasonally adjusted employment rose by 40 in March

Seasonally adjusted nonfarm payroll employment increased by 40 in March to 9,410 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to increase by 40 jobs, but the county added 80 jobs. The private sector added all 80 jobs, and total government employment was unchanged. Leisure and hospitality added 50 jobs. Manufacturing grew by 30 jobs. Other industries had smaller changes.

March's total nonfarm employment numbers show a gain of 50 jobs compared with one year before, an increase of 0.5%. The county lost 1,260 jobs in April 2020 as the pandemic hit, and as of March it remained down 120 jobs from March 2019, before the pandemic. Manufacturing grew by 80 jobs over the past year to March. Other services added 40 jobs. Leisure and hospitality lost 110 jobs during the year. Local government, including education, regained 70 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 4.5% in March, essentially unchanged from 4.7% in February. It was 4.0% the year before. The statewide unemployment rate was 4.4% in March, and the national rate was 3.5%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
