Employment in Tillamook County: March 2024

Seasonally adjusted employment decreased by 40 in March

Seasonally adjusted nonfarm payroll employment decreased by 40 in March to 9,650 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to increase by 70 jobs, and the county added 30 jobs. The private sector gained 40 jobs, and total government employment decreased by 10. Leisure and hospitality added 50 jobs. Local education lost 20 jobs.

March's total nonfarm employment numbers show a gain of 20 jobs compared with one year before, an increase of 0.2%. Manufacturing, mining and logging, and other services each gained 20 jobs over the past year to March. Retail trade lost 50 jobs during the year. Government gained 60 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 4.0% in March, unchanged from 4.0% in February. It was 4.6% the year before. The statewide unemployment rate was 4.2% in March, and the national rate was 3.8%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
